

## **DATA PROCESSING NOTICE – “YES TO PADS” CAMPAIGN**

1. **Controller.** The controller of your personal data collected in connection with the organisation of the “YES to Pads” social campaign (the “**Campaign**”) is the **KULCZYK FOUNDATION** with its registered office in Warsaw (00-526) at ul. Krucza 24/26, entered in the Register of Associations, Other Social and Professional Organisations, Foundations, and Independent Public Health Care Institutions, and in the Register of Entrepreneurs of the National Court Register [KRS] kept by the District Court for the Capital City of Warsaw in Warsaw, 12th Commercial Division of the National Court Register under KRS no: 0000471002, holding NIP [Tax Identification Number]: 70104114847 (the “**Foundation**”). 2. **Data Protection Officer.** The Foundation has appointed a Data Protection Officer, who can be contacted on all matters related to privacy and data protection by email at [iod@kulczykfoundation.org.pl](mailto:iod@kulczykfoundation.org.pl).
3. **Purposes of processing your data.** The Foundation processes your personal data provided in connection with signing the petition to the authorities as part of the Campaign to:
  - (a) pursue the Foundation's legitimate interests consisting in carrying out its statutory activities, including carrying out the Campaign and recording your support for the petition to the authorities (Article 6(1)(f) of the GDPR);
  - (b) pursue the Foundation's legitimate interests consisting in informing persons interested in the Campaign about its further progress (Article 6(1)(f) of the GDPR), whereby the Foundation will process your data for this purpose only if you agree to receive information regarding the Campaign to your email address.
4. **To whom may the Foundation disclose personal data?** The personal data you provide may be disclosed by the Foundation to:
  - (a) its employees, associates, in particular those who are involved in carrying out the Campaign;
  - (b) organisations and entities supporting the Campaign, especially those participating in the Periodic Coalition;
  - (c) providers of services, software, and IT systems that the Foundation uses to carry out its statutory activities, including the Campaign;
  - (d) entities that provide services supporting the statutory activities of the Foundation, such as accounting services, legal and business consulting services, IT equipment maintenance services, financial services, marketing services—only to the extent necessary to provide such services.

The list of people who have signed the petition to the authorities may also be forwarded to the public authorities who are the addressees of the petition.
5. **Will the Foundation transfer personal data outside the EEA?** The Foundation will not transfer the acquired personal data outside the European Economic Area.
6. **How long will the Foundation process personal data?** The Foundation will process personal data for the entire period of the Campaign.
7. **What rights do data subjects have in connection with the Foundation’s processing of their personal data?** You have the right to:
  - (a) access your personal data;
  - (b) request their rectification, erasure or restriction of their processing;
  - (c) lodge a complaint in connection with the processing of your personal data with the supervisory authority, i.e. the President of the Personal Data Protection Office in Warsaw;
  - (d) to the extent that your personal data are processed on the basis of the premise of the Foundation’s legitimate interests—to object to the processing of your personal data;

- (e) as the legal basis for processing your data is the Foundation's legitimate interests, you do not have the right to portability of your personal data;
  - (f) with respect to the consent to receive information on the Campaign, if you have given it—you can withdraw your consent at any time by sending a message to [iod@kulczykfoundation.org](mailto:iod@kulczykfoundation.org) or by clicking the unsubscribe link included in the messages that are sent to you. Withdrawal of consent will not affect actions taken on its basis prior to its withdrawal.
8. **Is it mandatory to provide personal data?** Providing personal data is necessary to sign the petition. The consent to receive information on the Campaign is voluntary.
9. **Will the Foundation use personal data to make automated decisions, including profiling?** No.
